

REBA "TOURIST" FLYAWAY SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT ENHANCE YOUR CHANCES OF WINNING.

Sponsor: Music Corporation of America, 222 2nd Ave South, Suite 2200, Nashville TN 37201 ("**Sponsor**" or "**MCA**"). Sponsor's decisions are final and binding in all matters relating to the Reba "Tourist" Flyaway Sweepstakes ; referred hereafter as the "Sweepstakes."

Sweepstakes Entry Period: The Sweepstakes entry submission period for the Sweepstakes begins at 12:00:00 A.M. Central Standard Time ("**CST**") on August 31, 2026, and ends at 11:59:59 P.M. CST on September 14, 2026 ("**Sweepstakes Entry Period**").

Eligibility: Sweepstakes is open to any person who has reached the age of twenty-one (21) years or older in the state or territory where they reside and who at time of entry is a legal resident of the forty-eight (48) contiguous United States including the District of Columbia, excluding residents of the state of New York and Florida ("**Territory**"). Void in AK, FL, HI, NY and where prohibited by law. Employees of the Sponsor, Reba ("**Artist**"), and their respective parent company, subsidiaries, affiliates, advertising and promotion agencies, and any other individual or company involved in the development or execution of the Sweepstakes (collectively the "**Released Parties**") and their immediate family members and/or those living in the same household of each are not eligible to enter or win. Sweepstakes is subject to all applicable federal, territorial, and local laws and regulations.

To Enter: You may enter the Sweepstakes in one (1) of three (3) ways. You may enter the Sweepstakes by visiting <https://RebaMcEntire.lnk.to/TouristSweeps> ("**Website**") and following all onscreen instructions to i) connect and save selected Reba tracks via Spotify music service ("**Service Provider 1**"). After clicking "connect and save on Spotify" and completing the entry form by providing your first name, last name, email address, country and clicking "Submit," you are officially entered into the pool of eligible entries ("**Spotify Entry**"); or ii) connect and save selected Reba tracks via Apple music service ("**Service Provider 2**"). After clicking "connect and save on Apple Music" and completing the entry form by providing your first name, last name, email address, country and clicking "Submit," you are officially entered into the pool of eligible entries ("**Apple Entry**"), or iii) you may also enter by clicking "No thanks, I just want to enter the Sweepstakes" and following the onscreen instructions by providing your first name, last name, email address, country and clicking "Submit". After clicking "Submit," you are officially entered into the pool of eligible entries ("**Online Entry**"). If you do not have a Spotify account, you may visit www.spotify.com and create an account for free and sign into your newly created Service Provider 1 account to enter. If you do not have an Apple Music account, you may visit www.apple.com/ and create an account for free and sign into your newly created Service Provider 2 account to enter. To obtain up to three (3) bonus Entries, you may follow all onscreen entry instructions to sign up to receive email and/or SMS updates from Reba by checking the appropriate sign-up box and/or sign up to receive email updates from MCA by checking the appropriate sign-up box. Once properly checked and submitted, the information you supplied via your Entry will be collectively considered and referred to herein as your "Bonus Entries." Only three (3) Entries per person regardless of Entry method. To be eligible for the random drawing, all Entries must be received by 11:59:59 PM CST on September 14, 2026. On or about 12:00:00 P.M. CST on September 14, 2026, a potential winner will be chosen at random from all eligible Entries received during the Sweepstakes Entry Period.

Limit: Four (4) Entries per person regardless of Entry method during the Sweepstakes Entry Period. Entries received in excess of limit of entries and entries received after the end of the Prize Entry Period are automatically disqualified. Only complete and valid entries as determined by the Sponsor will be

eligible for the Sweepstakes. By participating in the Sweepstakes, each participant is confirming that they have read and agree to comply with these Terms and Conditions (“**Rules**”), Sponsor’s terms of use, located at <https://privacypolicy.umusic.com/terms/> and all other Sweepstakes requirements.

Normal Internet access and data usage charges imposed by your carrier or online service will apply. All Entries become Sponsor’s property and will not be returned or acknowledged.

Use of any automated system to participate is prohibited and will result in disqualification. If an entrant submits more than the number of Entries allowed by these Rules, and/or if the Sponsor suspects that an entrant attempted to obtain additional Entries by using multiple email addresses and/or email accounts, registrations, identities or any other method, or if an entrant submits an entry on behalf of another individual, all Entries submitted by the entrants will be declared null and void, and the entrant may be disqualified from participation in the Sweepstakes at the Sponsor’s sole discretion. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected entries, which will be disqualified. Only the “authorized email account holder” may enter this Sweepstakes. In the event of a dispute regarding the identity of an entrant, the dispute will be resolved in favor of the individual who is the "authorized email account holder" of the email address or service provider account provided at time of Entry.

“Authorized email account holder” is defined as the natural person assigned an email address by an Internet access provider, online service provider, or other organization (i.e., business, education institution) responsible for assigning email addresses for the domain associated with the submitted email address. Each potential winner may be required to show proof of being the authorized email account holder. Sponsor can disqualify an individual if their conduct is contrary to the spirit or intention of the Sweepstakes.

Winner Selection: One (1) prize winner will be selected at random by Sponsor from among all eligible Entries received during the Sweepstakes Entry Period. The selection of a potential winner of the Sweepstakes will be conducted on or about 12:00:00 P.M. CST on or about September 15, 2026, at the offices of the Sponsor. The Sponsor’s decisions are final and binding. An email prize notification will be sent to the potential winner on or around September 16, 2026, based on the information provided by participant on Entry. Potential winner (and potential winner’s guest) must be twenty-one (21) years of age or older and will be required to execute and return an Affidavit of Eligibility, Liability, Publicity Release (“**Affidavit/Release**”) and any other required documents as determined by the Sponsor or Sponsor’s agent and, unless prohibited by law, within forty-eight (48) hours of date and time specified on the prize notification or they will be disqualified, and an alternate potential winner may be selected. If any potential winner fails to respond to any direct message and/or prize notification sent to them by email within forty-eight (48) hours of transmission or if the Affidavit/Release, or if prize notification email is returned as undeliverable; or if a potential winner has failed to execute and return the Affidavit/Release, or any required document within the specified time period; or if potential winner is otherwise found to be ineligible; or if the selected potential winner cannot accept or receive the prize for any reason; or if the prize is returned undeliverable, the potential winner will forfeit the prize and an alternate potential winner will be selected from all non-winning eligible Entries. The alternate potential winner will be notified and be bound by the same conditions and timelines as stated in these terms and conditions. Prize will be awarded within thirty (30) days after winner’s verification. Should winner be found to have made any false statement(s) in the Affidavit/Release, or any required document, that winner will be disqualified and required to promptly return to Sponsor their prize. Except where prohibited by law in any eligible state or territory stated in these Rules, entry and acceptance of prize constitutes permission for Sponsor and/or any third party associated with the Sweepstakes to use each

winner's first name, last name initial and country for fulfilling any winner's list requirements as required by U.S. promotion law.

Except where prohibited by law, entry and/or acceptance of prize constitutes permission for Sponsor and their respective agents to use winner's and/or guest's name, prize won, hometown, likeness, video tape, photographs, and statements for purposes of advertising, promotion and publicity (including online posting) in any and all media now or hereafter known throughout the world in perpetuity, without additional compensation, notification or permission. ARV of prize: \$8,998.00. Prize specifically consists of: one way coach airfare for two (2) to/from a major commercial airport nearest to winner's primary residence to Denver, CO (flights may include stopovers and/or connections) and one way coach airfare for two (2) from/to Moab, UT to a major commercial airport nearest to winner's primary residence; one (1) rideshare credit to be used for round trip ground transportation between airport/hotel/train station; two (2) nights double occupancy hotel accommodations (one (1) room, room and tax only) at Sponsor's choice of hotel in Denver, CO **and** Moab, UT; two (2) tickets for a three-(3) day rail experience with Canyon Spirit (train seat location and other accommodations to be determined in Sponsor's sole discretion). Any additional ground transportation, food, beverages, merchandise, parking, taxes, gratuities, incidentals, upgrades, service charges or any other expenses not specified herein are not included and are winner's sole responsibility. If actual value of prize is lower than the stated ARV when prize is procured and fulfilled, the difference will not be awarded. Winner will be required to provide all hotels with a credit card at time of check-in to cover incidental fees/damages along with providing complying with any requirements mandated by the hotel's management. No substitution of prize (or portion of prize) offered, no transfer of prize to a third party is permitted and no portion of prize may not be redeemed for cash value, except by Sponsor, who reserves the right in its sole discretion to substitute prize or any portion of the prize for a prize of comparable or greater value.
