

## **BOB MARLEY SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**A PURCHASE WILL NOT ENHANCE YOUR CHANCES OF WINNING.**

**Sponsor:** 1755 Broadway, New York, NY 10019 (“**Sponsor**” or “**UMe**”). Sponsor’s decisions are final and binding in all matters relating to the Bob Marley Sweepstakes; referred hereafter as the “**Sweepstakes**”.

**Sweepstakes Entry Period:** Sweepstakes begins at 12:00:00 P.M. EST on 6/2/26 and ends at 12:00:00 P.M. TIME ZONE EST on 6/30/26 (“**Sweepstakes Entry Period**”).

**Eligibility:** Sweepstakes is open to any person who has reached the age of thirteen (13) years or older in the state or territory where the person resides and who at time of entry is a legal resident of the fifty (50) United States including the District of Columbia (“**Territory**”). Void where prohibited by law. Visit <https://www.islandrecords.com/> (“**Website**”) during the Sweepstakes Entry Period and follow all onscreen entry instructions to enter your first name, last name, email address, country and click “Submit”. Once properly submitted, the actions you completed will be considered and referred to herein as your “Entry.” To obtain two (2) bonus Entry, you can sign up to receive email updates from Bob Marley and/or Island Records by checking the appropriate sign-up box. Once properly checked and submitted, the information you supplied via your Entry will be collectively considered and referred to herein as your “**Bonus Entry.**” At the end of the Sweepstakes period, a potential winner will be chosen at random from all eligible Entries received. Only three (3) Entries per person. To be eligible for the random drawing, entries must be received by 12:00:00 P.M. EST on 6/30/26.

By submitting an Entry, you hereby agree to hold Released Parties and their respective affiliates and subsidiaries, and the officers, directors and employees of each of the foregoing, harmless from and against any liability of any kind arising from or in connection with any use of the Entry. The Sponsor reserves the right to prescreen the submitted Entries and/or disqualify any Entry for any reason. Sponsor is under no obligation to disclose why an Entry has been disqualified other than the Entry was ineligible under these Rules. Entries are subject to all notices posted online including Sponsor's privacy policy. **Winner Selection:** One (1) prize winner will be selected at random by Sponsor from among all eligible Entries received during the Sweepstakes Entry Period. The random drawing will be conducted within seventy-two (72) hours of the Sweepstakes Entry Period end date. An email prize notification will be sent to potential winner's Account within seventy-two (72) hours of the random drawing based on the information provided by participant on Entry.
