

2026 MCA VINYL STARTER PACK GIVEAWAY OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

The 2026 MCA Vinyl Starter Pack Giveaway (the “**Sweepstakes**”) begins at 08:00:00 AM Central Time (“**CT**”) on 6/1/26 and ends at 11:59:59 PM CT on 6/12/26 (the “**Entry Period**”). The Sponsor’s agent’s computer server will be the time-keeping device for the purposes of this Sweepstakes.

SPONSOR: Music Corporation of America, a division of UMG Recordings, Inc., 222 2nd Ave S, STE 2200, Nashville TN, 37201 (“**MCA**” or “**Sponsor**”) is solely responsible for all aspects of the Sweepstakes.

HOW TO ENTER: There are two (2) ways to enter the Sweepstakes. You may enter by 1.) using your mobile phone to scan the QR code featured on the Sweepstakes signage to be directed to <https://mca.lnk.to/MCAPresentsSweeps> and following all onscreen entry instructions to enter your first name, last name, email address, zip code, country, and clicking “Submit”. Upon clicking “Submit”, you are officially entered into the pool of eligible entries (“**QR Entry**”). Alternatively, you may enter the Sweepstakes by 2.) visiting <https://mca.lnk.to/MCAPresentsSweeps> (“**Website**”) during the Sweepstakes Entry Period and following all onscreen entry instructions to enter your first name, last name, email address, zip code, country and clicking “Submit”. Upon clicking “Submit”, you are officially entered into the pool of eligible entries (“**Online Entry**”). Both Entry methods into the Sweepstakes constitute your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use, and transfer your name, address, and other information for the purpose of administering this Sweepstakes. To obtain up to three (3) bonus entries, you can sign up to receive email updates from MCA by checking the appropriate sign up box, and/or sign up to receive email updates from Victrola by checking the appropriate sign up box, and/or sign up to receive email updates from Universal Music Group by checking the appropriate sign up box. Once properly checked and submitted, the information you supplied via your Entry will be collectively considered and referred to herein as your “**Bonus Entries**.” Only four (4) Entries per person regardless of entry method.

By participating in the Sweepstakes, each Entrant is confirming they have read and agrees to comply with: (i) these official rules (“**Rules**”); (ii) Sponsor’s terms of use, located at <https://privacy.umusic.com/terms> and (iii) all other Sweepstakes requirements. Each of such potential Entries will be disqualified and any attempt by a person to use multiple cell phone accounts to register more than once may result in disqualification at Sponsor's sole discretion. Prize winner will receive one (1) MCA Vinyl Starter Pack consisting of: one (1) Victrola white automatic turntable; one (1) Little Big Town – 'Pain Killer' **Signed** Vinyl; one (1) Jon Pardi – 'California Sunrise' **Signed** Orange Vinyl; one (1) Carter Faith – 'Cherry Valley' Vinyl; one (1) Tucker Wetmore – 'What Not To' Vinyl; one (1) George Strait – '#1's Vol. 1' Blue Vinyl; one (1) Toby Keith – '13 Number Ones' Red & Clear Marble Vinyl; one (1) Reba McEntire – "Trailblazer (With Miranda Lambert and Lainey Wilson)" 7" Vinyl and one (1) Luke Bryan – "Country Song Came On" / "Play It Again" 7" Vinyl. Approximate retail value ("ARV") of Prize: \$514.90. Final artist selections and specific vinyl titles included in Prize to be determined in Sponsor's sole discretion and are subject to change.
