

**THE ROLLING STONES BIGGEST EVER PRIZE DRAW**  
**TERMS AND CONDITIONS**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**A PURCHASE WILL NOT ENHANCE YOUR CHANCES OF WINNING.**

- 1. PROMOTER:** The Promoter of this prize draw is Polydor Records, a division of Universal Music Operations Limited of 4 Pancras Square, London, N1C 4AG, U.K. referred to hereafter as the "Promoter".
- 2. PRIZE DRAW ENTRY PERIOD:** The Rolling Stones Biggest Ever Prize Draw (referred hereafter as the "Prize Draw") begins at 17:00:00 P.M. Greenwich Mean Time ("GMT") on the 26 day of January 2026 and ends at 17:00:00 P.M. GMT on the 9 day of March 2026 (the "Entry Period").
- 3. ELIGIBILITY:** Prize Draw is open to any person who has reached the age of 18 or older in the state, province or territory where s/he resides and who at time of entry is a legal resident of any of the following "Territories": Canada, France, Germany, the Netherlands, the United Kingdom (defined as: England, Northern Ireland, Scotland and Wales) or the 50 United States, including the District of Columbia (collectively referred to hereafter as "Entrant"). Residents of any country or territory not mentioned herein shall not be eligible to enter or win. The Prize Draw is void where prohibited by law. Employees of the Promoter, and its respective parent company, subsidiaries, affiliates, advertising and promotion agencies, and any other individual or company involved in the development or execution of the Prize Draw, and The Rolling Stones ("Artist") (collectively the "Released Parties") and their immediate family members and/or those living in the same household of each are not eligible to enter or win. Prize Draw is subject to all applicable federal, provincial, territorial and local laws and regulations.

- 4. HOW TO QUALIFY FOR AND SUBMIT A MAIN ENTRY AND BONUS ENTRIES:** To enter and receive one (1) "Main Entry" in the Prize Draw, (1) visit <https://link.fans/therollingstones> ("Prize Draw Site") and follow all onscreen instructions to submit your first name, last name, email address and country and click "Enter". After clicking "Enter," you are officially entered once into the pool of eligible entries. To earn an optional "Bonus Entry", follow all onscreen instructions to sign up to receive email update from The Rolling Stones by checking the appropriate sign-up box and click "Submit". Once properly submitted, your Bonus Entry will be entered into the pool of eligible entries. A Limit of one (1) Main Entry and one (1) Bonus Entry per person will be allowed during the Entry Period. Only complete and valid Entries as determined by the Promoter will be eligible for the Prize Draw. All Main and Bonus Entries submitted in accordance with these Rules shall be hereinafter referred to as eligible "Entry" or "Entries". All Entries become the property of the Promoter and will not be acknowledged or returned. Promoter may, in its sole discretion, disqualify any Entry that Promoter deems to be in violation of these Rules at any time. In event of

a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed to be submitted by the person whose name appears on or who was assigned email account. Any use of automated or programmed methods of spamming Entry (including AI generated content) is prohibited. Neither the Promoter, Released Parties, nor any of its officers, directors, shareholders, employees, agents, artists or representatives of the Promoter or Released Parties (individually a "Released Party" and collectively the "Released Parties") are responsible for Entries from persons residing, or physically located, outside any Eligible Territory; or Entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, irregular in any way, late, lost, misrouted, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Rules; or for any printing, production, technical, electronic or other errors; or for lost, interrupted or unavailable network, server or other connections; miscommunications; failed phone or computer hardware or software or telephone transmissions; technical failures; unauthorized human intervention; traffic congestion; garbled or jumbled transmissions; undeliverable emails resulting from any form of active or passive email filtering; insufficient space in Entrant's Account to receive email; or other errors of any kind, whether due to electronic, mechanical or human error or other causes; even if caused by the negligence of any of the Released Parties.

Winners may be required to show proof of being the authorized account holder of the email account associated with the Entry. Any Entrant who attempts to enter with multiple email accounts or under multiple identities will be disqualified. The Promoter is not obligated to communicate with any Entrant during the duration of the Prize Draw.

5. **RESTRICTIONS:** Normal Internet access and data usage charges imposed by your carrier or online service will apply. 6. **WINNER SELECTION & WINNER NOTIFICATION PROCESS:** Thirty (30) prize winners will be selected at random by Promoter. Prize Draw will be executed/conducted using a computer process

that produces verifiably random results. Prize Draw will be conducted on or about 12:00:00 P.M. GMT on or about the 11 day of March 2026 at the offices of the Promoter (Polydor Records, 4 Pancras Square, London, N1C 4AG, U.K.). An email prize notification will be sent to each potential winner by the 12 day of March 2026 based on the information provided by participant upon Entry; and with respect to the United Kingdom, potential winners will need to respond to Promoter's email within forty-eight (48) hours with their physical mailing address. Except for any potential winner from the United Kingdom, or any applicable territory in the European Union, winners may be required to execute and return a Declaration ("Declaration") or Affidavit of Eligibility / Liability / Publicity Release ("Affidavit/Release") as determined by the Promoter or Promoter's agent (unless prohibited by law) within five (5) days of date specified on the prize notification or he/she will be disqualified, and an alternate winner will be selected. - c. One (1) third prize ("Third Prize") winner will receive one (1) Rolling Stones x Nixon Time Teller Gold Watch. ARV of Third Prize: £206 / \$275.00 USD.
- d. Five (5) fourth prize ("Fourth Prize") winners will each receive one (1) Rolling Stone Mystery Box of music from The Rolling Stones. ARV of each Fourth Prize: £150 / \$200.00 USD.
- e. Five (5) fifth prize ("Fifth Prize") winners will each receive one (1) Rolling Stones Mystery Box of merchandise from The Rolling Stones. ARV of each Fifth Prize: £150 / \$200.00 USD.
- f. Five (5) sixth prize ("Sixth Prize") winners will each receive one (1) bottle of Limited-Edition Subversive Scent. ARV of each Sixth Prize: £99 / \$132.00 USD.

- g. Ten (10) seventh prize ("Seventh Prize") winners will each receive one (1) Subversive Scent Discovery Set. Total ARV of each Seventh Prize: £35 / \$46.00 USD.
- h. One (1) eighth prize ("Eighth Prize") winner will receive one (1) Crossfire Hurricane Rum Accessory / Pourer Set. ARV of Eighth Prize: £30 / \$40.00 USD.

In the United Kingdom, Promoter will not in any circumstances be liable to compensate the winner or accept any liability for any loss, damage, disappointment or injury occurring as a result of entering the Prize Draw or taking up the prize. Nothing in these Rules shall limit in any way any

party's liability under the law of England and Wales for death or personal injury caused by its negligence. Nothing in these Rules shall affect your statutory rights.

In all applicable territories, Promoter is not responsible for any suspension of the Prize Draw or inability to implement the Prize Draw or award any prize as contemplated herein due to any event beyond its control, including delays or interruptions caused by acts of God, acts of war, natural disasters, weather, utility outages, acts of terrorism or any federal, state, or local government law, order, or regulation, order of any court or regulator.

In all applicable territories except the United Kingdom, ANY CLAIMS, JUDGMENTS, AND/OR AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS ASSOCIATED WITH ENTERING THIS PRIZE DRAW.
