Effective Date: October 15, 2025

These Terms & Conditions ("Terms") govern your subscription to the Tauren Wells email list operated by Home-team Touring, Inc. By subscribing to the Tauren Wells email list, you agree to be bound by these Terms and our Privacy Policy.

1. ACCEPTANCE OF TERMS

By providing your email address and submitting the Tauren Wells email list sign-up form (whether hosted on Capitol Christian Music websites, Universal Music Group websites, social media platforms, or other channels), you acknowledge that you have read, understood, and agree to be bound by these Terms and our Privacy Policy.
