

NOAH KAHAN SIGNED STICK SEASON ANNIVERSARY SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT ENHANCE YOUR CHANCES OF WINNING.

Sponsor: Mercury Records, a division of UMG Recordings, Inc., 1855 Broadway, New York, NY 10023 ("**Sponsor**"). Sponsor's decisions are final and binding in all matters relating to the Noah Kahan Signed Stick Season Anniversary Sweepstakes; referred hereafter as the "**Sweepstakes**".

Sweepstakes Entry Period: Sweepstakes begins at 11:50:00 AM EST on 10/14/25 and ends at 11:59:59 AM EST on 10/28/25 ("**Sweepstakes Entry Period**").

Eligibility: Sweepstakes is open to any person who has reached the age of eighteen (18) years or older in the state or territory where the person resides and who at time of entry is a legal resident of the fifty (50) United States including the District of Columbia ("**Territory**"). Void where prohibited by law. Employees of the Sponsor, Noah Kahan ("**Artist**") and their respective parent company, subsidiaries, affiliates, advertising and promotion agencies, and any other individual or company involved in the development or execution of the Sweepstakes (collectively the "**Released Parties**") and their immediate family members and/or those living in the same household of each are not eligible to enter or win.
