

UDISCOVER MUSIC VINYL SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

Sponsor: Universal Music Enterprises, a division of UMG Recordings, Inc., 2220 Colorado Ave., Santa Monica, CA 90404 (“**Sponsor**”) is solely responsible for all aspects of the uDiscover Music Vinyl Sweepstakes; referred hereafter as the “**Sweepstakes**”.

Sweepstakes Entry Period: Sweepstakes begins at 12:00:00 A.M. Pacific Time (“PT”) on 6/15/26 and ends at 11:59:59 PM PT on 6/26/26 (“**Sweepstakes Entry Period**”).
