

MOTOWN X JACKSON 5 PRIZE PACK GIVEAWAY OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT ENHANCE YOUR CHANCES OF WINNING.

Sponsor: Motown Records , a division of UMG Recordings, Inc., 1750 North Vine Street, Hollywood, CA 90028 (“**Sponsor**”) is solely responsible for all aspects of the Motown x Jackson 5 Prize Pack Giveaway; referred hereafter as the “**Sweepstakes.**”

Sweepstakes Entry Period: Sweepstakes begins at 9:00:00 A.M. Pacific Time (“PT”) on 4/20/26 and ends at 11:59:59 PM PT on 5/20/26 (“**Sweepstakes Entry Period**”).

Eligibility: Sweepstakes is open to any person who has reached the age of thirteen (13) years or older in the state or territory where the person resides and who at time of entry is a legal resident of the fifty (50) United States including the District of Columbia (“**Territory**”). Void where prohibited by law. The random drawing will be conducted within seventy-two (72) hours of the Sweepstakes Entry Period end date. An email prize notification will be sent to potential winner's email account within seventy-two (72) hours of the random drawing based on the information provided by participant on Entry.
