After providing your first name, last name, email address, city, zip code, country and clicking "Submit," you are officially entered into the pool of eligible entries ("**Apple Entry**"), or iii) you may enter by clicking "No thanks, I just want to enter the sweepstakes" and following the onscreen instructions to provide your first name, last name, email address, city, zip code, country and clicking "Submit." Approximate retail value (“**ARV**”) of prize: \$1,637.98. All taxes, gratuities, incidentals, service charges or other expenses not specified herein are not included and are the winner’s sole responsibility. Arrangements for the fulfillment of a prize will be made by Sponsor and/or its designated agent. Certain restrictions may apply. No substitution offered or transfer to a third party is permitted.
